Dear Members of the NLU Tripura Fraternity Greetings!



The program's principal guest was Prof. (Dr). V. K. Ahuja, the Vice-Chancellor of NLUJA, Assam. The pupils were filled with a sense of respect due to his presence and the valuable experiences he offered. The first session of the first batch at the newest national law institution commenced, with the esteemed Professor (Dr.) V. K. Ahuja delivering the first lecture. Hon'ble Justice Sabyasachi Datta Purkayastha, High Court of Tripura graced the occasion as the Chief Guest and blessed students with his words of wisdom. Further, Mr. Ratan Datta, Chairman, Bar Council of Tripura also blessed the students with his presence.





CONSTITUTION DAY



The university held an online lecture on "Transformative Constitutionalism" to commemorate the 74th Samvidhan Divas (Constitution Day) on November 26, 2023. As the Chief Guest, Prof. (Dr.) P.S. Jaswal, Vice-Chancellor of SRM University in Haryana delivered the lecture. Prof. (Dr.) Yogesh Pratap Singh, Vice-Chancellor, National Law University, Tripura presided over the occasion. The distinguished professors of National Law University, Tripura, also took part in the online special lecture. Both B.A.LL.B. (Hons.) and LL.M. students actively participated in this captivating presentation and engaged in the question-and-answer session.





TRIPURA DIALOGUE FORUM

Tripura Dialogue Forum (TDF) is a platform created under the aegis of the National Law University Tripura. The Forum serves as a distinguished platform for intellectual discussions and engagement on a wide array of issues that hold substantial importance within the legal and socio-political spheres concerning the north-eastern region. The forum would look forward to bring together experts, scholars, policymakers, judges, lawyers, activists and bureaucrats to exchange ideas and to enrich the people with their valuable knowledge and widen their horizons of thought.

Tripura Dialogue Forum (TDF) under the aegis of National Law University, Tripura organized its inaugural expert talk on "Constitutional Ethos" delivered by Siddharta Shankar Dey, Advocate General of Tripura, on 2nd December, 2023. Advocate General Dey drew parallels between the ancient texts like *Upanishad*, epics like *Mahabharata*, religious texts like *Bhagavad Gita*, and the Constitution of India.

Comparing the epics and the Constitution of India he brought up the preamble - which was referred to as the 'identity card of the Constitution' by the eminent jurist and Constitutional expert Nani Palkhivala. Advocate Dey also mentioned the eternal concept of "Vasudhaiva Kutumbakam" meaning the whole world is one family. AG Dey drew a connection to Article 14 - equality before law, and Article 16 - equality of opportunity clause of the Constitution of India.

Through this lecture, Tripura Dialogue Forum has set the stage for immersive and vibrant discourse in the legal landscape of Tripura. The Vice-Chancellor, Prof. (Dr.) Yogesh Pratap Singh in his welcome address emphasized that TDF has been created to cultivate ideas that ignite innovation, embrace possibility and amplify social impact. Registrar, Prof. Nachiketa Mittal, Dr. Debasree Debnath, Assistant Professor of Law and TDF Coordinator were instrumental in organizing this event. Faculty members and students from National Law University Tripura, Government Law College and ICFAI Law School participated in the event.



INSPIRATIONS GALORE

Throughout the duration of the newsletter, numerous scholars from diverse academic domains made visits to the university, imparting their knowledge and skills to both students and faculty members. This served as a source of inspiration, motivating them to delve into various aspects that contribute to the comprehensive and all-encompassing advancement of the subject of law.

Three Days Workshop on Cyber Law and Cyber Security

The NLU, Tripura, organised a workshop on "Cyber Security" with the enthusiastic students of LL.M., recognising the significance of cyber law. Under the patronage and guidance of Prof. (Dr.) Nachiketa Mittal, Registrar and Dr. Ripon Bhattacharjee, Assistant Professor of Law and Ms. Pakhi Garg, a Cyber Law Expert and Founder of WCSF, conducted a three-day session on "Cyber Law and Cyber Security" from December 13th to 15th, 2023. The seminar commenced by providing a succinct introduction to the field of cyberlaws and cybersecurity. All the students acquired knowledge pertaining to the Artificial Intelligence, Act of the European Union, the techniques employed in cyber-squatting, and the underlying principles governing salami slicing and penny shaving. The course also addressed topics such as Distributed Denial of Service (DDoS) attacks, cyber terrorism, cyber pornography, and cyber espionage. The present analysis also encompassed significant legal cases, namely K.S. Puttuswamy vs. Union of India and Yahoo Inc. vs. Akash Arora (1999). On the second day, the speaker engaged in a comprehensive overview of the preceding day's conversations and thereafter delved into an examination of the worldwide and comparative perspective on cyberlaws and data protection. A comprehensive analysis was conducted on legal frameworks in India, Europe, and the United States. The speaker presented a thorough overview of the UNDRP policy and the Budapest Convention on Cybercrime (2001). Furthermore, the speaker examined the significance of the Digital Personal Data Protection Bill, 2023 and presented a comprehensive outline of the General Data Protection Regulations, and conducted an evaluation of the California Consumer Privacy Act, 2018. Vice-Chancellor, Prof. (Dr.) Yogesh Pratap Singh, expressed gratitude at the end of the session





Memorandum of Understanding (MoU)

National Law University, Tripura signed a Memorandum of Understanding (MoU) with National Law University and Judicial Academy, Assam on November 17, 2023 for the purpose of academic collaboration and enriched academic endeavour.









COTPA SURVEY

A Comprehensive End Line Compliance Survey to measure the compliance of Sections 4, 5, 6a, 6b, 7, 8, and 9 of the Cigarettes and Other Tobacco Products Act (COTPA) in eight districts of Tripura was undertaken by the Centre for Public Health Law and Policy, National Law University Tripura. The purpose of the survey was to measure the effectiveness of existing measures and identify areas for improvement in tobacco control policies in the State. The primary objectives of the survey were:

- 1. To evaluate compliance of Sections 4, 5, 6a, 6b, 7, 8, and 9 of COTPA in the eight districts;
- 2. To identify gaps and challenges in the implementation of tobacco control measures; and
- 3. To recommend actions for enhancing compliance and strengthening tobacco control efforts. The Report of survey will be submitted to the Government of Tripura.



FACULTY DEVELOPMENT PROGRAMME



The commencement of a five-day Faculty Development Programme (FDP) on Designing, Developing, and Delivering Online, Blended Learning Courses, organised by National Law University, Tripura, in partnership with NIEPA, New Delhi, signifies a noteworthy advancement in the modernization and enhancement of higher education in the Northeast region.

The five-day hybrid Faculty Development Programme (FDP) was inaugurated by Mr. N. C. Sharma, the Director of Higher Education for the Government of Tripura, from December 13th to 17th, 2023. Prof. Yogesh Pratap Singh, the Vice-Chancellor of NLU Tripura; Prof. K. Srinivas, the Chairperson of the e-Learning Cell at NIEPA; and Prof. Nachiketa Mittal, the Registrar of NLUT, were present at the inaugural ceremony. The Vice-Chancellor of NIEPA, Prof. Shashikala Wanjari, participated in the ceremony in virtual mode and restated the commitment of the government and NIEPA to furnishing the state of Tripura with high-quality educational materials, in alignment with the goals outlined in the new education strategy of 2020.

The main aim of the five-day Faculty Development Programme (FDP) is to provide faculty members from different universities and colleges in Tripura with the essential information, skills, and resources required to proficiently create, construct, and administer online and blended learning courses. This programme exemplifies the commitment of NLU Tripura and NIEPA to maintain a leading position in the implementation of innovative teaching approaches, acknowledging the significant influence of technology in contemporary education. Professors from NLU Tripura, M.B.B University, TIT, Tripura Government Law College, ICFAI University, and other colleges participated in the session.

NLU Tripura organised another Faculty Development Programme (FDP) on virtual mode from October 30-November 05, 2023 on "Teaching Pedagogy in Law Schools."


UNIVERSITY MILESTONES

75th HUMAN RIGHTS DAY

The 75th Human Rights Day was celebrated by National Law University, Tripura in commemoration of the diamond anniversary of the Universal Declaration of Human Rights (UDHR). The Human Rights Day commemoration programme titled "Human Rights Discourse on Human Rights Issues in North-Eastern Region: Remedies within the Contours of Indian Constitution" was organised by the Centre of Northeast Studies and Policy Research, under the auspices of NLUT on December 10, 2023. Hon'ble Justice Mr. S.G. Chattopadhyay, Former Judge, High Court of Tripura, and Mr. Purushuttam Roy Barman, Senior Advocate, High Court of Tripura participated in the event.

The formal commencement of the project occurred with the establishment of the Centre of Northeast Studies and Policy research, under the guidance of Dr. Dipikanta Chakraborty, the Director of the Centre. The programme, which was initiated under the guidance of Vice-Chancellor Prof. (Dr.) Yogesh Pratap Singh, aimed to address the human rights situation in Northeast India. The Vice Chancellor of NLUT provided a detailed explanation of the future strategy for this recently established NLU. Prof. Singh highlighted the significance of human values in order to fully experience human rights with a particular focus on the historical context of the Indian Constitution.





The Hon'ble Justice Mr. S.G. Chattopadhyay emphasised on several human rights concerns in the region of Northeast India. He advocated for the inclusion of human rights education in both public and private enterprises, encompassing healthcare facilities as well. Based on his extensive expertise, he elucidated the concerns pertaining to the widespread infringement of child rights instances of domestic abuse, and instances of medical incompetence in Tripura. He asserted that the Constitution of India is the outcome of a popular movement advocating for the rights of the people. Mr. Barman proposed solutions based on the provisions of the Constitution of India highlighting his strong commitment to addressing issues like bulldozer justice, custodial death, and minority discrimination.

University students enthusiastically engaged in the event and delivered a skit about the rights of endangered tribes. The presentation concluded with a formal expression of gratitude delivered by the convener, Dr. Dipikanta Chakraborty.




SPEECH COMPETITION


